Dear Food Vendor:

The Village of Montgomery is making plans for our 22nd Annual **GENERAL MONTGOMERY DAY** to be held September 10, 2011. We are seeking participation of various types of food vendors, however no one will have an exclusive on food or vendor spots.

The Village is planning a full day of activities including a parade, all-day band concerts and entertainment, historic displays, a soap box derby, fireworks and a large variety of antique and craft dealers.

The streets of the downtown area of the Village will be blocked off to accommodate all the activities and vendors. Village Food vendors will set-up in front of their Village business. We will also have space available for food vendors in the *new* Food Court, located in the center of all activity. **CLEAN WATER SUPPLY** will be your responsibility. We have electricity available, on a first come basis, for an addition \$25.00. We *encourage* you to use the electricity to cut down on the noise. Also, please provide a trash barrel to dispose of any waste created by your food preparation; including grease! The Village will provide trash barrels for your customers. We will require a **\$100.00** check, separate from the application fee, as a **clean up deposit**. **Your check will be returned if your vendor space is left clean and waste free.**

The *Out of Town Food Vendor* fee on this date is **\$500.00 per spot** and space rentals will be assigned to accommodate size of food trailers/trucks and to alleviate food duplications. This day is well publicized and over the years we have had as many as 20 thousand people in attendance.

We would like to have you participate in this year's **GENERAL MONTGOMERY DAY**. Please submit your application with a check for the fees indicated along with your certificate of Insurance indicating the Village of Montgomery and The General Montgomery Day Committee as an additional insured to my attention at the above address no later than August 19, 2011. Applications will not be accepted after this date. Only the food specifically listed on the attached application will be allowed to be sold on **GENERAL MONTGOMERY DAY**. **THERE WILL BE NO RAIN DATE.**

- 3. A CURRENT CERTIFICATE OF INSURANCE SHOWING THE VILLAGE OF MONTGOMERY AND THE GENERAL MONTGOMERY DAY COMMITTEE AS ADDITIONAL INSURED FOR SEPTEMBER 10th**
- 4. INCLUDE \$5.00 FOR EACH PARKING SPOT YOU REQUIRE**
