RE: MINUTES

Moved by Deputy Mayor Scheels, seconded by Trustee Andolsek, the Board approved the minutes of May 21, 2019. Motion carried, 5-Ayes, 0-Nays.

RE: ABSTRACT NO. 05 - 2019

Moved by Trustee Andolsek, seconded by Deputy Mayor Scheels, all bills listed on ABSTRACT NO.05-2019 were audited and approved for payment with \$ from the General Fund, \$123,925.81 from the Water Fund, \$5,101.59 from the Sewer Fund and totaling \$26,681.93. Check No: 76959 – 77027, 1392 - 1405. Motion carried, 5-Ayes, 0-Nays.

Treasurer Griffith reported a CASH BALANCE for the month of May 31, 2019, as follows: General Fund \$1,141,319.83, Water Fund \$243,339.98, Sewer Fund \$370,749.86.

RE: DEPARTMENT REPORTS – POLICE DEPARTMENT

Police Chief Walsh mentioned attending the Valley Central School Safety Committee meeting and they have decided not to contribute towards the funding for the police resource officer. He will add an extra patrol for June 23rd Rolling Thunder event.

RE: UNSAFE BUILDING OF 91 ROOSEVELT AVENUE

B/I Yancewicz reported on the unsafe conditions of 91 Roosevelt Avenue and measures for remediation are needed immediately. The house has 4.5 inch of water in the basement, there is evidence of black mold, and the live animals have been removed, as well as a deceased dog; of about three weeks. The electric has been off for weeks and the grass is about two feet high. He asked the Board to authorize him to lock it down. He will be calling the residents daughter, to try and save the building.

Moved by Trustee Lindner, seconded by Trustee Andolsek, the Board adopted an emergency resolution of an unsafe building at 91 Roosevelt Avenue and authorized the Building Inspector Yancewicz to lock down the resident. Motion carried, 5-Ayes, 0-Nays.

RE: DEPARTMENT REPORTS – DEPARTMENT OF PUBLIC WORKS

DPW Supt. Nelson reported AdEdge filling the vessels. He will need to launch a CodeRed for the flushing out the wells and cleaning the lines out. He also recommends scheduling Subsurface every six months, to flush the wells and clean out the lines, without fail. In addition, he would like to speak with the Board about acquiring more land from the Hoeffner's. They are in the process of negotiations. Mayor Brescia mentioned an appraisal would need to be done.

RE: STOP PEOPLE FORM DUMPING OF LEAVES ON DUNN DRIVE

Resident Richard Miller asked the DPW Supt. Nelson what measures are possible to stop people from dumping their leaves on Dunn Drive. He is not sure who may be doing this, but suspected it be to a local official. DPW Supt. Nelson said cameras may be the solution. Mayor Brescia suggested sending a letter to everyone that lives in the vicinity of Dunn Drive.

RE: ORIOLE DRIVE TRAFFIC

Mayor Brescia asked DPW Supt. Nelson to put up signage on Oriole Drive regarding the large trucks speeding. The Police Department will add Oriole Drive to the directive patrol. DPW Supt. Nelson asked if a No Truck is what should be installed, at the beginning of Oriole Dr. Mayor Brescia replied, yes. On another note, the CH poles signage need to be cleaned up.

Mayor Brescia mentioned that a fine of \$500.00 to \$1,000.00 would be imposed should their trucks travel through the Village, but isn't sure how it would be monitored. The other problem, we have is FedEx tractor trailers coming through the Village. Buddy stated receiving a delivery of a five gallon pail on a tractor trailer, with nothing else on the truck. We can send a follow up letter, addressing our concerns, before the SEQRA process is complete. The same questions was asked many times.

Atty. Dowd said, is not sure how they are going to make them pay a fine, when they would be using a state highway, which they are allowed to use. It is not under our control. He is not sure how a contract of that nature, can be valid. It sounds great! Why would you fine them for using a state highway? It's an illegal proper charge.

Police Chief Walsh said he is still investigating the training at the Police Academy with the State Police and the DOT.
